## Notes

*An EFIN is only required to electronically file any Federal Returns: 94X, 1040, 1041, 1065, 1120, 1120S, 990. You can obtain this 6-digit number through the IRS.*

**Note 1:** The SACTAX Program Manager is required each year with any program. It controls printing, file utilities, client data roll-over, client organizers, lists and labels, and includes the Tickler Due Date Monitor.

**Note 2:** Required for multi-user environments. Restricts access when files are in use to avoid data corruption. Allows for customization of firm information, client letters, and client bills by user.

**Note 3:** 1120, 1120S, 1065, 1041 and F1120 programs handle returns for calendar year 2023 and fiscal years through November 2022. Users will also be able to access prior year Depreciation Tables.

**Note 4:** Depreciation Program handles depreciation for years through November 2023. It is included FREE when you buy any Federal Program.

**Note 5:** Standard weekly updates during tax season are available at no charge through the internet.

**Note 6:** The Payroll Tax Program includes Federal Forms 940, 941, 944, W-2, 1099, & State Payroll Forms (CO, CT, FL, GA, KY). Printed paper forms and electronic filing is available. E-filing is included at no additional cost. Includes E-filing for 25 EIN's.

If you would like to e-file the 940, 941 and/or 944 returns you must have a 6-digit EFIN and 5-digit PIN (IRS Issued).

**Note 7:** The multi-location license is required for each additional business location using the software. The cost of the license is 50% of the subtotal (per location).

**Note 8:** No refund requests will be granted after the SACTAX Installation email and/or CD have been sent out. By ordering the software you agree to these terms.

**Note 9:** The Florida Business Package includes the forms below for one company only FL Sales Tax, FL Tangible Tax, FL Payroll and a single federal form: 1120, 1120S, 1065, or 990.

**Note 10:** Sales tax program includes up to 25 certificates. Over 25 is additional \$10.00 per year each certificate.
